CONDITIONS

The Rules of Racing of the Ontario Racing Commission in effect at the time these race are contested shall govern these races and any and all entries to the races will be received only with the understanding and on the agreement of the subscriber that the Rules of Racing govern, and that the following additional conditions apply:

1. All horses can be claimed for \$10,000.00 (plus allowances) from the elimination and the final.
2. The nomination fee of \$200.00 is **due no later than Friday, August 1st, 2014.**
3. If 11 or more horses declare to start, the race will be contested in eliminations. If 10 or less horses declare to start, the race will be contested as a single Final dash.
4. All horses must be declared to start in the elimination races and Finals, by the regular box closing date and time.
All draws held at Clinton Raceway: 519-482-5270
5. When eliminations are required - All Finals will be limited to nine (9) horses plus one (1) also eligible from the highest money earners from the eliminations. If one of the nine highest money winners fails to declare in for the final, the next highest money winner declared will become eligible to the final. If the number of horses tied in money earnings for the last eligible starting position increases the field to more than nine horses, they will be drawn by lot to constitute a nine horse field. If enough money winners fail to declare in for the final, starters in the series that are not money winners and declared for the final may increase the field to nine horses, and such horses will be drawn by lot.
6. In the event that there are twenty (20) or fewer nominations for these events, the race may be declared off and all money returned as paid.
7. All races to be raced over a distance of one mile (1609 M).
8. Purse distribution: 50 per cent, 25 per cent, 12 per cent, 8 per cent, 5 per cent.
9. Georgian Downs reserves the right to cancel the race without liability therefore upon repayment of all subscription fees, if any, paid on such cancelled race.
